GPDR IN THE FAAV

INTRODUCTION

The purpose of this document is to clarify **FAAV's** policy with respect to the General Data Protection Regulation, and is effective as of September 2022.

The **Argentina Virtual Air Force** complies with the General Data Protection Regulation (GDPR) and the applicable Children's Online Privacy Protection Acts of 1998 (COPPA).

This policy has been implemented with the following objectives:

- To comply with data protection law and regulations and online privacy protection.
- To ensure good data protection practices.
- To protect members, staff and other individuals.
- To protect minors, the **Argentina Virtual Air Force** limits the age of entry, pilots must be a minimum of 18 years of age to apply for membership. If there are any applicants under the age of 18, it is permissible for them to join as long as they obtain signed consent from their parent/guardian for the data collection process.

Data to be collected:

- First and last name
- Date of birth
- E-mail address
- Country and city
- VATSIM / IVAO ID if applicable

Consent to collect data:

We collect information about you when you register for **Argentina Virtual Air Force** login, complete a form or submit any external information through a third party application (i.e., logging into Discord, for example.).

You can enter our website anonymously.

By logging into **Argentina Virtual Air Force** and using our site and services, you are **Argentina Virtual Air Force** permission to collect personal data that will only be used by **Argentina Virtual Air Force**.

How we use your Information:

Argentina Virtual Air Force uses your data for the purpose of recording, among others, participation as a group member, flight logs, pilot progress.

We may also communicate with you by e-mail, this will be on a strictly necessary basis and only when making announcements of upcoming events or important information related to the **Argentina Virtual Air Force**.

Any information we collect from you may be used in the following ways:

- To maintain your active pilot status. - Your information helps us establish and update your profile, as well as track your progress and hours.
- To personalize your experience: your information helps us to better respond to your individual needs.

- To improve our operations. - Your information helps us to effectively streamline our operations as a Virtual Special Operations Airline.
- To send periodic e-mails. - The email address you provide may be used to send you information, respond to inquiries and/or other requests or questions.

Data Retention:

Argentina Virtual Air Force will not retain your data after you have been removed from our Pilot List.

You may delete your data at any time by contacting us and requesting to delete your virtual account with **Argentina Virtual Air Force**.

Distribution:

We do not sell, trade or otherwise transfer to outside third parties any of your personal information data. This does not include trusted third party software that assists us in operating our website or servicing you, so long as those parties agree to keep this information confidential. We may also release your information when we believe release is appropriate to comply with the law, enforce our site policies, or protect ours or others rights, property, or safety.

We will be transparent about our practices so that you can make meaningful choices about how your personal information is used. If we make a material change, we will provide you with a notice on this website page and/or notify you through our discord channel or by email (if you have provided us with an email address).

Data Controller:

User data collected by **Argentina Virtual Air Force** is managed by the **Argentina Virtual Air Force** management team, which implements a variety of security measures to maintain the security of our personal information when you enter, submit or access your information.

Please note that we cannot guarantee that any data transmission over the Internet is completely secure.
